## Greetings from the ILEA Alumni President!

ILEA recently held the annual Contemporary Issues and Ethics Conference: Police, Protests and Public Places – Balancing Rights and Obligations, where the focus was on the Occupy Movement. What a great conference it was, too! From finding ways to keep tent cities from destroying and bankrupting local government resources to learning key phrases and points to best handle media inquiries, the conference was chock full of information and ideas on protecting the rights of citizens who have peaceably assembled to protest their plight, while maintaining a sense of order and safety. As one attendee commented, “the First Amendment doesn’t stop at 11pm.”

Notably, Dr. Gary W. Sykes, retired Director of ILEA and Vice President of CAIL, was present to deliver the capstone comments of the conference. The ILEA Center for Law Enforcement Ethics awarded the Ethical Courage Award posthumously to the parents of Arlington, Texas police officer Jillian Smith, who sacrificed her life by shielding a child from gunfire at a domestic disturbance in 2010.

The Contemporary Issues Conference is also the venue for the annual meeting of the ILEA Alumni Association. For the 2012 48<sup>th</sup> Management College, the Alumni Association awarded a tuition scholarship to Charlottesville Police Department. Business of the Association included discussion on strengthening local ties between alumni and yet to be named regional directors. Regional directors will be able to more easily reach out to graduates in their respective areas, and find ways to keep them connected to each other and to the Institute. Associate Director Gregory Smith discussed a new program format for the School of Police Supervision that will be offered at the Fort Worth Alliance Center.

The new format will consist of holding the school in four one-week per month sessions. This new format will allow an agency that cannot afford to send a supervisor away for an entire month to spread that training over a period of time. ILEA Director Neil Moore discussed ILEA's name recognition and reputation around the country, and marketing strategies to further expand the brand and visibility of ILEA in order to attract more students to ILEA programs. The Center for Law Enforcement Ethics is working on several contracts to take the Ethics Train-the-Trainer program to locations across the nation.

Attendance at the Association business meeting was disappointing. Seven members in good standing (including Life Member James Long, Ret.) were all that attended. The Association meets as a body annually, and needs better representation and involvement than seven members. In 2011 the by-laws were changed to make the organization more flexible and responsive. Association staff assistant Tracy Harris, is (as always) the marvelous and organized center of the universe who keeps the Association's books, sells the ILEA memorabilia, and otherwise keeps the organization afloat. However, the profit margin on memorabilia is not enough to sustain the Association. We are counting on you to support the Alumni Association with your dues. There are a little more than two dozen paid members at this writing. At \$25 per year (about the price of one vending machine soft drink per week), paid memberships provide the Association with the ability to continue scholarships. With consistent paid memberships, the Alumni Association could explore more training opportunities, and

potentially provide better networking, information, and connection within our membership. Because ILEA includes the Association in the ability to join or renew online, it couldn't be easier.

### Dr. Gary W. Sykes Award for Professional Achievement

Dr. Gary W. Sykes, retired Director of the Institute for Law Enforcement Administration and Vice President of The Center for American and International Law, was the inaugural recipient of the newly established Dr. Gary W. Sykes Award for Professional Achievement.

Dr. Sykes served for over fifteen years at the Center and Institute. In 1992, with the support of a \$600,000 grant from the Meadows Foundation, he helped to establish the internationally-known Center for Law Enforcement Ethics.

Gary has also conducted funded research projects for the Bureau of Justice Statistics, U.S. Department of Justice; has authored numerous articles in professional journals; has written several chapters in law enforcement administration textbooks and currently is writing a police administration text to be published in the near future.

Gary received his Ph.D. in Political Science from Pennsylvania State University in 1977, and has served on the faculties of Berea College, the University of Wisconsin-Superior, and the University of Louisville.

Married to Bonnie for over forty years, he has three children; four grandchildren and one great-grandchild.

Dr. Sykes has served the law enforcement community for over forty years.

## Ethical Courage Award

At the conclusion of the 2012 Contemporary Issues and Ethics Conference, the Ethical Courage Award was presented posthumously to Mr. Douglas and Mrs. Sonya Smith in honor of their daughter Officer Jillian Smith, who died heroically, in the line of duty in 2010.

At a domestic dispute in Arlington, Texas, Jillian was shot while shielding and saving the life of an 11-year old girl from gunfire. The gunman, Barnes Samuel Nettles, 38, killed his ex-girlfriend, Kimberly Carter, 29, and then fatally shot Jillian before committing suicide.

The Annual Ethical Courage Award is intended to recognize an individual or organization for especially meritorious leadership or courage related to law enforcement ethics and integrity. Officer Smith's actions displayed absolute loyalty and commitment to the ethical, courageous and caring values found in the most exemplary of law enforcement officers.

Officer Smith earned a Bachelor of Arts degree in Criminology and minored in Sociology from the University of Texas at Arlington in August 2009. She was a member of the Mount Olive Baptist Church in Arlington.

### Ethics Train-the-Trainer

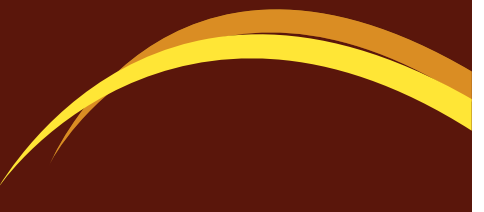
May 15-18, 2012
